What recommendations does Boise State have to scale these programs?

- Make resources available to any student in the state to access a WBL from a financial standpoint. To provide equitable access, there needs to be a funding source so that students can participate even if the employer can't pay them.
- Increase messaging to employers about the return on investment of work-based learning.

#### **Educator Externship Program**

Mr. McFarlane and Mr. Thomsen provided an overview of the Teacher Externship program:

- Started in 2019 to provide teachers and career counselors with practical experience outside of education.
- Educators work 200 hours and are paid a \$5,000 stipend for the summer.
- 16 placed in 15 businesses in 2019; 42 externs and 36 business planned for 2020 ended up with 27 externs.
- 18 of the 24 employers contributed to stipends in 2020 only one in 2019.
- Applications are open until February 12 for both teachers and employers.

## Idaho Apprenticeship Coalition Update

IDOL – working to restructure team to support anticipated growth in registering programs based on WDC and CTE's grants. Provided training on outreach to internal IDOL staff. Idaho has 192 sponsors total, 348 apprenticeship programs, 1,557 active apprentices.

CTE – all five subawards are now in place. Working on performance management system with WDC and shared CRM among all the partners.

IBE/WDC – IBE is getting close to placing the first youth apprentices under the grant in meat cutting (grocery store chain in Eastern Idaho) and auto tech. There is also interest in drone operators, lending, and many others.
