new branding. She demonstrated the functionality of the website: <a href="https://nextsteps.idaho.gov/resources/next-steps-idaho-connections">https://nextsteps.idaho.gov/resources/next-steps-idaho-connections</a> and walked the committee through the various tools and functions. Discussion:

- The Committee felt that "educator" might be more inclusive language than "teacher" because there are a lot of after school programs that are utilizing this tool.
- The Committee noted that homeschool communities have been using this tool effectively as well.
- The Committee recognizes the contributions of Dr. Linda Clark in the effort to bring this tool to the State of Idaho.
- Members of the Committee met with the Pathful team, and they are very motivated to continue partnering with the WDC and with the State to pursue opportunities in education.

## **Next Steps Feedback from Committee**

Dr. Reberry requested feedback from the Committee on Next Steps as a tool for students. House Bill 24 (HB24) will be introduced in a few days. Part of this bill requires students to participate in career prep and planning to benefit from Idaho Launch funding.

- Ms. Pretti requested the source of the career data on Next Steps.
  - Ms. Scudder responded that this data is taken from the Idaho Department of Labor which is free to us.
- Have we considered using Lightcast?
  - This has been a significant topic of conversation in the development of this product. We considered using different sources, but the truth is that at the state level there is a significant value in using consistent data across agencies.
  - Currently, the State Board doesn't have a contract with Lightcast.
- The Committee compared the visual/access of the adult users of this program to the 8<sup>th</sup> 12<sup>th</sup> grade user.
- If this is going to be connected to the Launch funds what is the extent to which a student is required to complete certain aspects of Next Steps?
  - Dr. Reberry clarified that will be a recommendation to the Council that this committee will develop.
- The staff will continue to work on this and when the legislation is introduced, we will allow it to guide integration and expansion.

#### **Child Care Expansion Grant Updates**
