\$3M available
Applicants are serving 2 separate Public Safety entities, one Police, one Fire
Both Ada County
National Law Enforcement Foundation also serving Canyon County
Both could move forward if requests were reduced.
One Option to fund 1 only, put Valley Learning Center into pool of general applicants.
National Law Enforcement Foundation hours are 17 per day.
The Valley Learning Center hours are 12 per day.
National Law Enforcement Foundation all slots for first responders.
Valley Learning allotted only 22 spots for first responders.
National Law Enforcement Foundation \$30,000 per seat.
Valley Learning Center \$3600 per seat
The Valley Learning Center is not applying directly for Public Safety, saw Fire as a partner.
