Ms. Hastings presented an overview of LinkedIn and how it could potentially enhance the public workforce system's ability to connect both those seeking employment and employers seeking qualified employees.

- Professional Networking Platform
- Vision: Create economic opportunity for every member of the global workforce
- Why it matters for workforce.
 - 73% of Workforce in Idaho are on LinkedIn.



- Worldwide
 - 1B members
 - 50K skills listed.
 - 30M companies
 - 20M jobs
- 50% of all employees will need reskilling by 2025.
- 68% of job seekers don't understand what skills are needed.
- 50% don't know how to gain the skills.
- Applicants are 4x more likely to get hired when they leverage their network.
- LinkedIn empowers seekers.
- 91% of employers report no qualified applicants for the positions posted.
- 79% of global CEOs had concerns over skills.
- LinkedIn can help:
 - Plan
 - Develop
 - Connect
- The state of Idaho currently has accessibility through Equus.
- 97% of Fortune 500 use LinkedIn to source and hire
- 70% of professionals get hired at companies where they already have a connection.
