Foster Care Furniture Innovation Grant

Foster Care Furniture will work with the Maker Shop and the College of Western Idaho to offer program participants a 12-week class in woodworking and cabinetry/furniture making. The program will be designed and delivered as a Pre-Apprenticeship Program that will prepare participants to enter available Registered Apprenticeship Program (RAP). The Maker Shop will work with CWI to develop a Carpentry

and Cabinetry Registered Apprenticeship Programs with CWI as the sponsor and Maker Shop as the related instruction provider. The course will be offered at the Maker Shop, in Boise, ID. The preapprenticeship program will develop skills for individuals in areas that include, but are not limited to, safely operating in a shop environment, project planning, furniture design, marking & measuring, cabinetry, woodworking, hand tools, power tools, and basic carpentry skills. Foster Care Furniture will work with partners to train 32 participants during the 24 months of the grant.

Funding Requested \$198,440.00

Realoq Employer Grant

Realoq is a Texas real estate broker, located in California. Realoq operates as a multi-sided real estate marketplace and technology company that offers a suite of products and services designed to streamline and optimize various facets of real estate transactions. The company operated throughout the United State and internationally. The company has established an operations center in Meridian, Idaho and will hire 125 individuals to fill 24 unique positions within the company during the grant period. Training offered by the employer will be provided internally and focus on services developed by Realoq as well as industry specific training required for real estate transactions. Business development and customer service make up 87 of the 125 positions to be hired.

Funding Requested \$218,750.00

Industry Training Associates Industry Sector Grant

Industry Training Associates (ITA) is seeking grant funds to expand its current course offerings to employers in the mining, heavy equipment, and manufacturing industry. ITA will work with industry partners to identify skills needed by industry and provide training that will primarily focus on basic electrical (both AC and DC), electrical safety training, advanced electrical diagnosis and repair, automation, and controls training - including PLC training. Provided training will be customized based on the employers' and industry's needs. Funding will be used to update current training aids and materials, purchase and develop new training aids, assist with travel costs to remote on-site employer locations, and to develop and produce training materials. ITA will train 460 participants during the grant's performance period.

Funding Requested \$639,000.00

Boise State University Industry Sector Grant

Boise State University, through its advanced manufacturing workforce development initiative, "Make Idaho", will develop a training pathway to prepare individuals for the advanced manufacturing (AM) industry. The program will support four main objectives including: infrastructure improvements, education and professional development opportunities, robust public-private partnerships, and increased collaboration between Idaho institutions. The new infrastructure will complement our established AM efforts which further helps to diversify the AM workforce, specifically targeting three key areas: AM of next-generation materials, AM in the biomedical field, and AM for extreme environments. This initiative will create courses that provide foundational AM knowledge for employees and employers, expose non-technical professionals to processes specific to additive manufacturing and materials development, and expand student's knowledge of AM in various industries. Specific skills training is focused through short courses and workshops in healthcare, next-generation materials, AM and extreme environments, and cross cutting short courses in finite element methods and patterning. Short courses offering skills badges will be integrated into an AM, and undergraduate courses will incorporate hands on experience and demonstrations of instrumentation in AM technologies. As part of the pathway initiative, introductory lessons will be held for k-12 students participating in Aerospace Days.

Funding Requested \$999,993.50

Idaho State University Industry Sector Grant

Idaho State University's College of Health is proposing an expansion of its comprehensive patient simulation and virtual training center. The expansion will allow ISU to increase its nursing, medical, and allied health programs by 35%. The expansion will impact students located in Idaho Falls, Pocatello, Meridian, and Coeur d'Alene. This project will add a new simulator center in Pocatello and upgrade equipment at current locations in Idaho Falls, Meridian, and Coeur d'Alene. During the grant period ISU will serve 400 individuals with 380 completing various programs under the College of Health. The expansion will serve program completers earning professional degrees in healthcare including Bachelor of Science in Nursing, Doctor of Nursing Practice, Registered Occupational Therapist, Physician Assistant, Registered Dental Hygienist licensed medical laboratory scientist and radiological technicians.

Funding Requested \$1,829,633.30
