• University of Idaho IKEEP – Innovation Grant

The University of Idaho's Indigenous Knowledge for Effective Education Program (IKEEP) began in 2016. Through their proposal, U of I will expand IKEEP's offerings by strengthening and diversifying the education workforce by developing wraparound career pathways to better serve American Indian/Alaskan Native (AI/AN) students in the region. IKEEP's wrap around career pathways will improve and address current teacher and education leader workforce development gaps in four areas: student engagement, student mentorship in career exploration, educational leadership cohorts, and design and deliver of an Indigenous education teaching and leadership development series (Offered statewide to 200-250 teachers who will receive a professional development credit). Training will be provided at the University of Idaho (Moscow) and distance centers across the state, including Coeur d'Alene, Boise, and Idaho Falls center. Training for professional development will be provided on-site in partnering schools and districts in Idaho, and on-line through virtual webinars and distance training. During the grant period the IKEEP program will serve 350 individuals. This number includes 260 already employed individuals who will receive training during grant.

Amount Requested: \$999,988.21

• College of Western Idaho – Industry Sector Grant

Based on the NFL draft, the CWI Construction Combine is designed to connect high school students with employers in the construction industry. In this two-day education to application event, employers will teach basic skills and students will show off their abilities. The event concludes with hiring opportunities that can directly connect participants to jobs. Students who successfully complete the program will receive a certificate of completion and access to CWI's Work-Based Learning Center where they can receive career counseling and job placement support if desired. Training will be provided in the CWI service area, which includes Ada, Canyon, Gem, Boise, Owyhee, Washington, Payette, Valley, and Elmore Counties. Students participate in the program free of charge. This program is modeled after ISU's successful, existing construction combine.

program, and the ability to expand the employer partnerships that make new training and job opportunities
available to Idaho's veterans. The project will also continue to provide job placement assistance, networking

• Nez Perce Youth Apprenticeship Program – Innovation Grant

The Nez Perce Tribal Employment Rights Ordinance Office (TERO) worked with Idaho Business for Education to create a Tribal Youth Apprenticeship Program (TYAP) in 2023. This grant will expand the existing TYAP program and add a healthcare program to expand students' opportunities to receive training and learn about careers in construction and healthcare. The program will collaborate with regional employers to identify areas of need and will use this information to develop additional apprenticeships that connect local youth to local employment. TERO is partnering with Baker Technical Institute who host a five-week construction training on site at the Nez Perce Reservation. Training will include OSHA 30, First Aid/CPR & AED, Blood Bourne Pathogens, Confined Spaces training, Basic Concrete 40 hrs. The healthcare program will use a virtual reality system called TRANSFER. TRANFER will be used as a pre-requisite for students to learn about jobs and training before entering a apprenticeship or pre-apprenticeship program. The TRANSFER program will also be used for the construction program.

North Idaho College Mechatronics – Industry Sector Grant

North Idaho College will develop two educational pathways - a for-credit and a non-credit option - that yield practical skills and credentials in advanced manufacturing. The project will expand the existing mechatronics education and training by increasing the 1-year certificate program from 12 to 20 seats. It will also expand the capacity of the University of Idaho and North Idaho College 2+2 transfer program and expand the outreach and awareness of advanced manufacturing trades and related careers. This project will also feature an outreach component through a one-week summer industry experience cohosted between NIC and Wagstaff, Inc., plus additional recruitments across the five counties in North Idaho.

Amount Requested: \$734,895.76

• University of Idaho Cleanroom - Industry Sector Grant

This grant expands the facilities and equipment that will support two new certificates (semiconductor design and microelectronics fabrication) and the NGeM program. Certificates are only 12 credits each, allowing students in aligned degree tracks to add a certificate without pursuing a new major or minor, and making the certificate more accessible and appealing for students. Recruitment of new students will focus on rural areas, and industry experts will be involved throughout the project to build and refine the course content to most closely align to industry needs. Additionally, industry professionals will participate in the program as guest lecturers to directly connect students to real-world knowledge. Students will obtain credentials including a Bachelor of Science degree in electrical engineering, computer engineering, chemical engineering, mechanical engineering, applied physics, and chemistry, or an undergraduate certificate in semiconductor design and microelectronics fabrication.
