- Policy change request
- Some projects have not spent funds received completely or will not be utilizing their award
- Repayment in process, reallocating available dollars
- Projects have been identified to receive additional funding
- The Child Care Expansion Grant Committee has been dissolved, allowing for changes to policy by this body
- The Executive Committee is approving the redistribution of recaptured funds
- Current policy approved March 6, 2024 by full Council
- Changes requested
 - Additional language in purpose statement "Pursuant to S1408..."
 - Additional bullet under fund availability
 - If funding is available, Council may award additional funds above the application request amount, within the maximum of \$15,000.00 per child served.
- If additional funds are awarded, the match would still have to meet the 50%
- Process for choosing recipients based on
 - More seats than planned are created
 - Performance

- Prioritization given to infant care
- Regional considerations
- Insurance that original premise is met
- Only option for ARPA funds is to reallocate, no new awards can be given after December 31, 2024
- Original SOW is used, no changes are made

LAUNCH Updates

Sherawn Reberry

- JFAC presentation by Ms. Secrist went very well on November 5th
- Annual report due December 14
- 5764 2026 Student LAUNCH applications received, 1800 more than last year at this time
- IBE meeting feedback, marketing seems to have been reduced after year 1
 - Yes, that is correct
 - Reduced budget
- 75% of 2024 applicants that submitted were awarded
- Currently at 75% in October for Class of 2025 versus 75% in December for Class of 2024
- 2024, 18% college enrollment increase, less the next year naturally
- New marketing materials for 2026
