

- Vision
 - How we are addressing the balance of meeting the needs of Idaho employers
 - We are serving our local communities
- Goals
 - Council goals are the start of these collaborative goals
 - Come from Executive Order from the Governor
- Strategies
 - Council continues to look at and refine
 - How we are connecting and working to reach these goals
 - Defines expectations
 - We do not change these; we determine the focus areas that we are going to work on
 - Communication Strategy continue to keep?
 - Important, yes keep it as priority
 - Is it something that may be asked to eliminate
 - Most of our programs have eligibility criteria
 - List of words that cannot be used just came out
 - Keep it broad in wording
 - Deliverable: May tie into IDOL SNAP Project for landing page, more cohesive
 - Coordinating Business Services across Partners
 - Still a priority? Yes, VR teams are providing leadership across regions
 - Building workforce system capacity to receive participants
 - Need some finessing regarding words used
 - Training successes
 - Open up to receive additional participants – make it general
 - Striking digital access
 - Service to Youth
 - Continue to have clear opportunities with group
 - Focus language on training and job opportunities, flip the narrative to focus away from the groups to occupations; AI ID Matrix
 - Career pathways and sector partnerships
 - required
 - TPM, Perkins, etc. here
 - Aligning to Americas Talent Strategy
 - Apprenticeship successes
